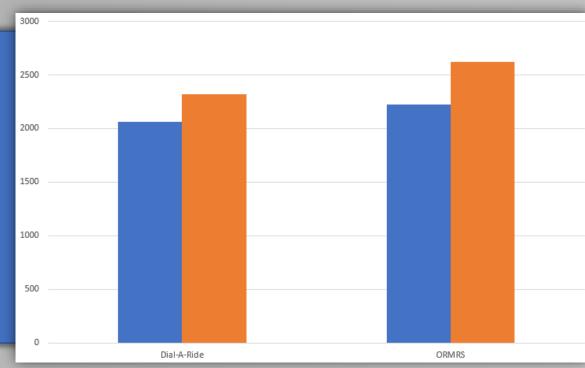

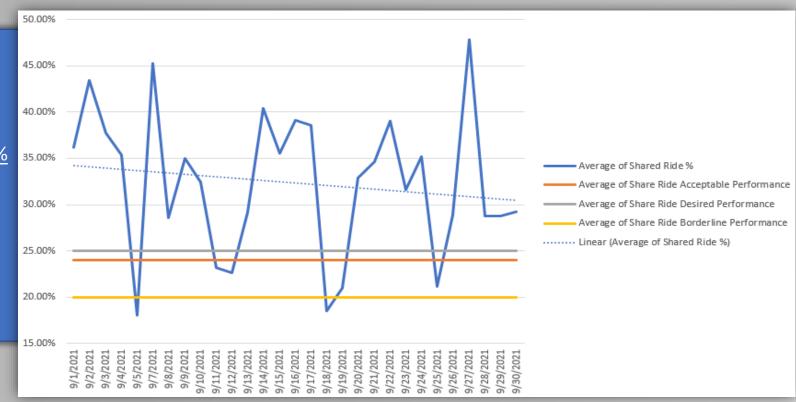

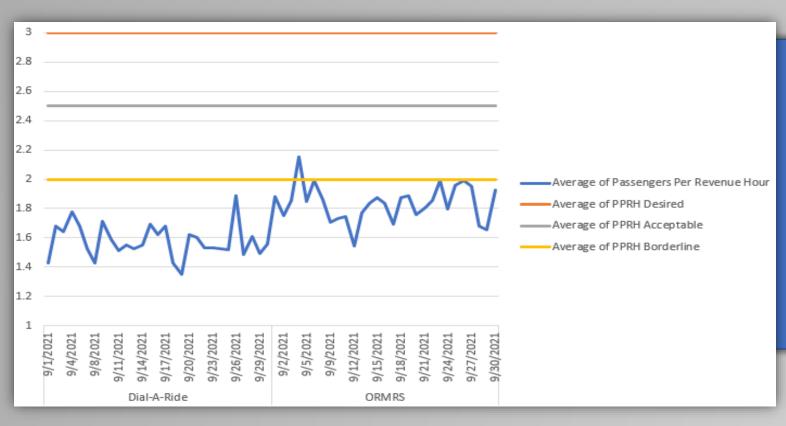

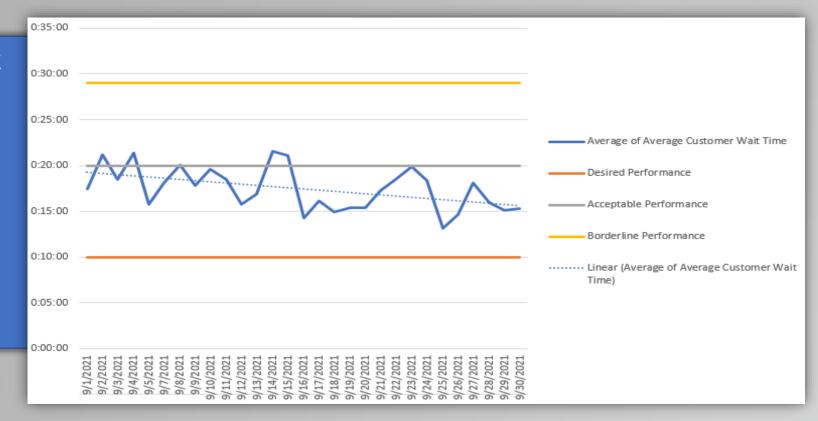

Hybrid and Zero-Emission Truck and Bus Voucher Incentive Program



The Hybrid and Zero-Emission Truck and Bus Voucher Incentive Program (HVIP) will open October 28th to new voucher requests.

Approximately \$62 million – 3rd round of funding. Available on a first-come, first-served basis.

- ➤ Will be applying for:
 - Eight 40-foot buses @ \$138,000 each = (\$1,104,000)
 - > Six 30-foot buses @ \$138,000 each = (\$828,000)

Secured 10 vouchers for 60-ft articulated buses in 1^{st} round @ \$138,000 each = (\$1,380,000)

California State Transportation Agency

(CalSTA) recently released the formal draft guidelines for the Transit and Intercity Rail Capital Program (TIRCP) 2022 Award Cycle for public and legislative review.

CalSTA expects to release final program guidelines and a call for projects on November 19.

Applications due: March 3, 2022

Public Employees' Pension Reform Act of 2013

On Friday, October 8, USDOL officially submitted notice to the United States District Court for the Eastern District of California, noting that it "will withdraw its prior determination with regard to the impact of PEPRA on collective bargaining rights, and will issue a new determination concluding that PEPRA does impermissibly impair the continuation of collective bargaining rights under Section 13(c)."



DEBT CEILING



On October 7, Congress approved a deal to increase the debt ceiling and keep the country solvent into December.

Senators voted 50-48 on the short-term increase in the nation's borrowing limit.

The bill still needs to pass the House before being sent to President Biden's desk.



Build Back Better

The White House continues to negotiate with key Members of Congress on the cost and content

The President floating a price range of \$1.9-\$2.2 trillion, down from the original \$3.5 trillion.



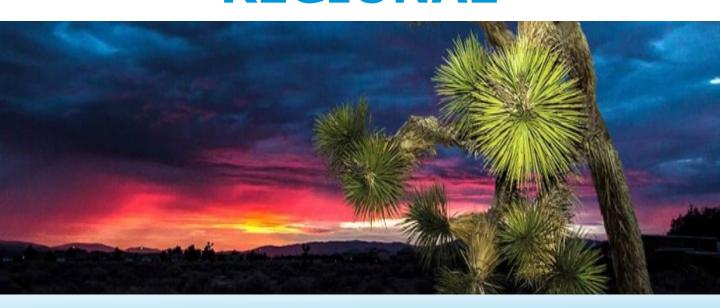

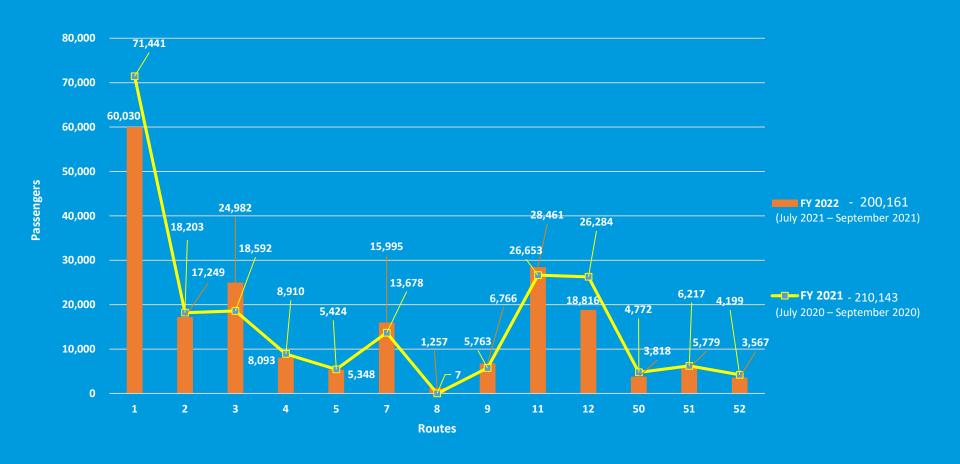

Microtransit vs Routes 50, 51 & 52



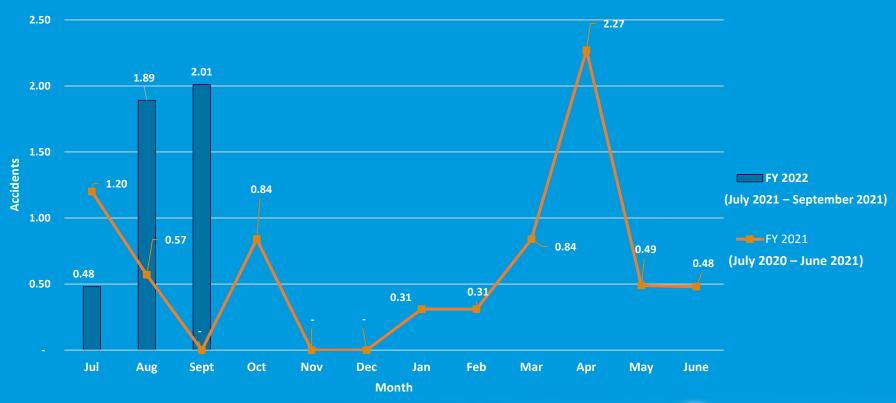

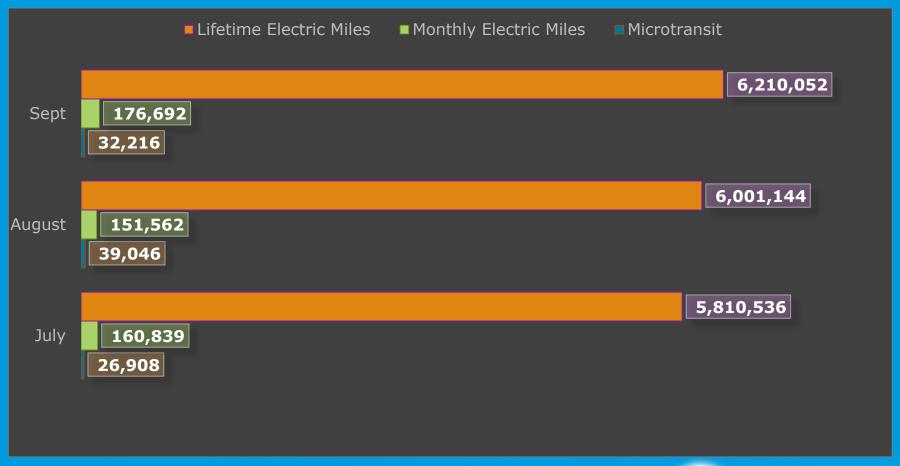

ELECTRIC MILES TRAVELED



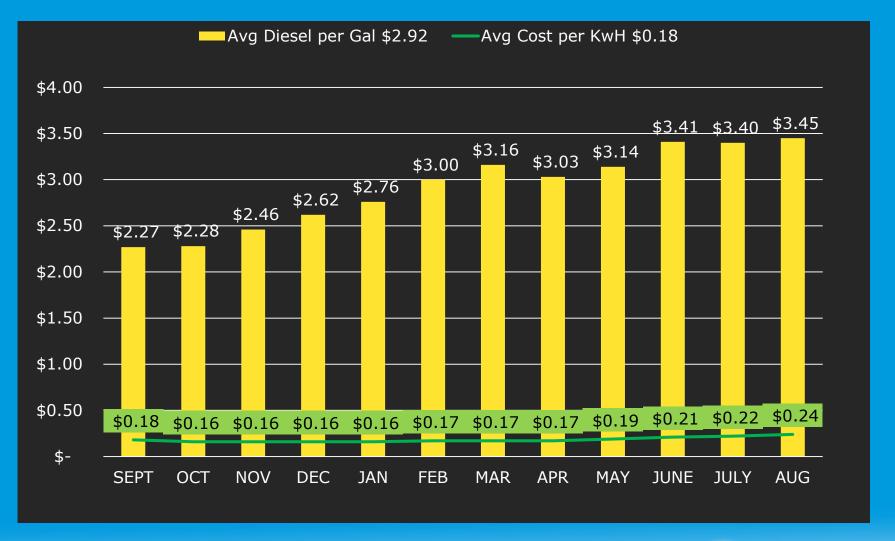


MAINTENANCE COST PER MILE BY FLEET



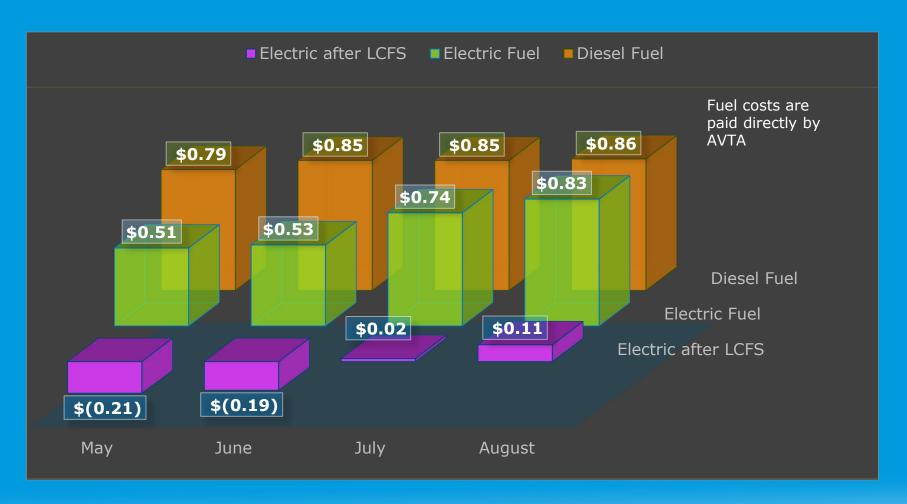


FUEL/ENERGY COST PRIOR 12 MONTHS





PROPULSION FUEL COST PER MILE w/LOW CARBON FUEL STANDARD (LCFS) OFFSET





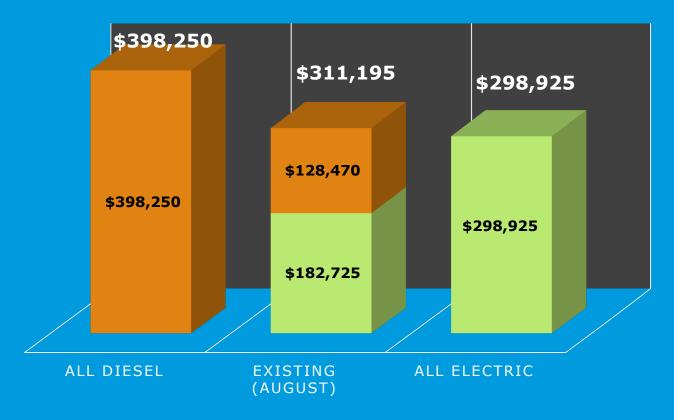
AVERAGE FUEL CONSUMPTION PER MILE (KWPM)

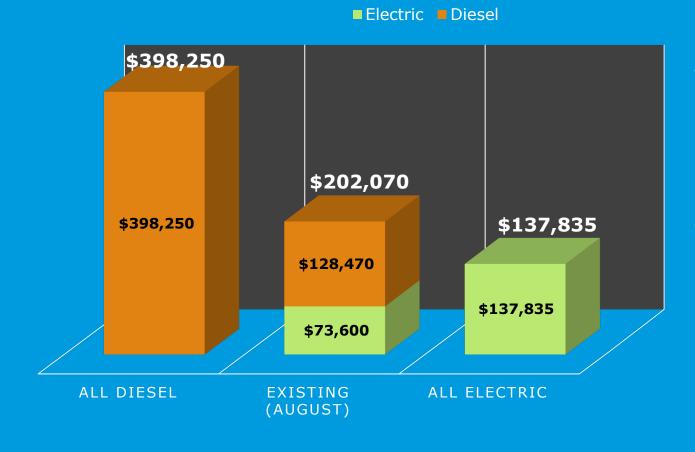

AVERAGE MILES BETWEEN SERVICE INTERRUPTIONS

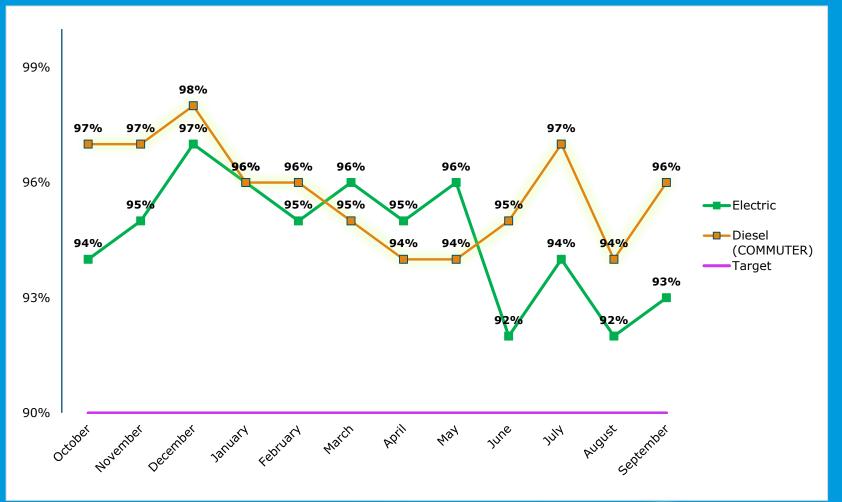

PUBLIC BUSINESS – AGENDIZED AND NON-AGENDIZED ITEMS:

Fran Sereseres – spoke about issues she is having reserving a ride on the Dial-A-Ride (DAR) service. AV Transit Management President Art Minasyan stated that it

could be difficult making reservations during peak times or if there is a shortage of vehicles. The Board discussed the DAR App available on the AVTA website and noted that many riders may not have a smartphone to access this option. Chairman Crist directed Mr. Minasyan to meet with Ms. Sereseres to resolve her issues.

SPECIAL REPORTS, PRESENTATIONS, AND REQUESTS FOR DIRECTION (SRP):

SRP 1 PRESENTATION TO TRANSDEV OPERATOR AND EMPLOYEE OF THE MONTH FOR AUGUST 2021

Chief Operating Officer Martin Tompkins introduced Transdev's new General Manager Denis Jackson. Mr. Jackson awarded the Operator of the Month for August posthumously to Sterling Singleton in celebration of his life and contributions to AVTA and Transdev. Mr. Jackson read the many kind sentiments shared by Transdev and AVTA staff members. Mr. Sterling's Aunt June Thompson accepted the award on his behalf. Mr. Jackson presented an award to the Employee of the Month Evette Serrano.

SRP 2 PRESENTATION TO ANTELOPE VALLEY TRANSPORTATION SERVICES (AVTS) EMPLOYEE OF THE MONTH FOR AUGUST 2021

AV Transit Management President Art Minasyan presented an award to the Employee of the Month Tony Hines.

SRP 3 LEGISLATIVE REPORT FOR SEPTEMBER 2021

Chief Financial Officer Judy Vaccaro-Fry presented an update for Assembly Bill (AB) 917, AB 970, the Clean California Local Grant Program, potential increased TSA civil penalties on individuals who violate the federal mask mandate, Executive Order 14037 - new rules aimed at reducing automobile emissions, pilot program for a national motor vehicle per-mile user fee, the Build Back Better Act and new federal grant opportunities. The Board briefly discussed AB 917.

SRP 4 OPERATIONS KEY PERFORMANCE INDICATORS (KPI) REPORT

Director of Operations and Maintenance Esteban Rodriguez presented the report. The Board reiterated that the passenger pass-ups are unacceptable. Chief Operating Officer Martin Tompkins explained that Uber picks up passed-up passengers with the costs passed on to Transdev. Director Hofbauer requested that operators notify the Authority when tree branches encroach into the bus stops.

SRP 5 MAINTENANCE KPI REPORT

Maintenance Compliance Manager Cecil Foust presented the report. He confirmed that maintenance costs per mile is an industry standard. Executive Director/CEO Macy Neshati provided a brief update regarding the Solar Field Project.

SRP 6 AVTS UPDATE (MICROTRANSIT AND DIAL-A-RIDE)

Mr. Minasyan presented the report. The Board discussed the types of vehicles used for the service. Chairman Crist directed Mr. Neshati to submit a grant to Antelope Valley Air Quality Management District (AVAQMD) to replace one of the gas-powered vehicles.

NEW BUSINESS (NB):

NB 1 STUDY TO EVALUATE AND RECOMMEND EQUITABLE METHOD FOR CALCULATING JURISDICTIONAL CONTRIBUTIONS

Executive Director/CEO Macy Neshati presented the staff report. Chairman Crist stated he received a correspondence from Supervisor Barger who was unhappy with comments made at the August Board meeting. He noted for the record that these were his comments, not Mr. Neshati's, and that he asked for the item to be included on the agenda. The Chairman stated he has yet to receive a call from the Supervisor's Transportation Deputy and has no interest in pretending like we are solving the problem. The Antelope Valley has to accomplish more with less as we are not allocated an equal share of funding. We do everything based upon industry standards and review everything based on a cost per mile. We cannot now invent new standards. It costs AVTA the same to drive from Lancaster to Lake Los Angeles with one person on the bus as it does with 20 people.

Los Angeles County Representative Vice Chair Knippel stated Supervisor Kathryn Barger wants to find the right solution to seek the cost of doing business. In the Supervisor's mind, it is not based on the cost per mile but on a range of things. The Supervisor suggested having the Los Angeles County Public Works department partner with the cities of Palmdale and Lancaster Public Works departments to craft the right contract, hopefully within 30 days. Vice Chair Knippel noted Appendix C of the JPA had not been updated since 1991, and many services and buses have been added since that time.

Motion:

AVTA Board of Directors direct Macy Neshati, our CEO, to return hopefully in 30 days with a recommendation for procurement of third party services in order to conduct a study that accesses the entirety of AVTA transit services and associated costs and that the results of which might form adjustments to Appendix C of the AVTA Bylaws.

I further move that the CEO's recommendation be based on input from transit experts from each member agency and contain a proposed scope of work that includes, but is not limited to, a review of the following: a review of service hours, review revenue service miles, proportional ridership surveys, maintenance and capital costs, special services and any other data consist with industry standards for calculating jurisdictional cost shares.

Moved by Vice Chair Knippel, seconded by Director Flanagan

Discussion continued.

Chairman Crist stated AVTA sends the Federal Transit Administration documentation every year based upon miles traveled. We are wasting taxpayer and agency money to do a repeat study. Mr. Tompkins confirmed the Authority submits data to the National Transit Data Base annually, such as vehicle miles traveled and vehicle revenue miles and hours. Chairman Crist stated industry standards no longer apply to AVTA. We are the industry standards and have set the rules for others to follow.

Speaking on this item:

John Huang, Transit Manager for Los Angeles County Public Works Department, stated he manages the Prop A local return fund for the County and pays the jurisdictional share to AVTA annually. The County is committed to paying its fair share and has made additional funding available annually. For example, Los Angeles County contributes to the microtransit service and years ago contributed to the first set of electric buses. We are committed partners with AVTA. He added that years ago, a similar study was completed with Santa Clarita Transit where various methods of calculating the fair share were reviewed. It was determined that revenue hours are a critical method of determining the fair share between different jurisdictions because buses travel faster in rural areas versus urbanized streets. However, the County is not saying any method is fair in the Antelope Valley areas. We are asking for a study, which could potentially change the method of the calculation. We are asking to take a fair look, not to contribute less.

Mr. Huang confirmed Los Angeles County's relationship with Santa Clarita is different from that of AVTA because the County is a partner with AVTA and in a contract with the City of Santa Clarita. Chairman Crist noted the City of Santa Clarita has 200 service miles that the County pays for, whereas AVTA has 1200 miles.

Mr. Huang stated the County has no issue paying by the mile. The issue is the commuter service. Many miles are contributed to the unincorporated area where the actual travel is within the City of Los Angeles. The majority of the passengers on the commuter buses are Palmdale and Lancaster residents. Therefore, calculating by miles on the commuter mode is not a fair split.

Chairman Crist asked if the cost should be on the jurisdiction of Palmdale when a passenger is traveling from Palmdale to downtown Los Angeles. Mr. Huang replied that if he and the Chairman were taking a taxi from the Antelope Valley to downtown Los Angeles, they would each pay half. If he, the Chairman, and another Board member took the same trip, the fare would be split into thirds. That is what the County is looking at and that is how the Bylaws were written in 1991. The conditions have not changed. The proportional rider in each jurisdiction can be reviewed.

Chairman Crist stated there was no service to Lake Los Angeles and very little service to Pearblossom or Littlerock in 1991. He reminded Mr. Huang and the Supervisor that every person AVTA serves belongs to the County. The Chairman agreed the County's relationship with the City of Santa Clarita is different because it is a contract. However, as a partner with AVTA, every jurisdiction has a 33 1/3% jurisdictional share regardless of the serviced area. He does not want AVTA to be in the position that Palmdale pays the cost when someone drives from Lancaster to Palmdale to board the bus.

Director Hofbauer added that it is almost impossible to profile each rider because there are so many County pockets in the Antelope Valley. We need to simplify and move forward. This is creating tension. We need adequate funding to provide superior service to our riders, which is their only form of transportation for many.

DISCUSSION

Deputy Maselli and his K-9 partner Doc worked a total of 640 hours during the first quarter of FY 2022.

At the beginning of each shift, Deputy Maselli contacted bus operators to ascertain if there were any concerns or problems to report, as well as anything that was reported from the previous day. On average, Deputy Maselli made contact with an estimated 25-30 buses/bus operators per day.

Deputy Maselli monitored various locations that had reported problems. These locations included Sgt. Steve Owen Memorial Park (OMP), Lancaster Senior Center, 6th Street East & Palmdale Boulevard, Palmdale Transportation Center (PTC) and the Lancaster Metrolink Station.

FISCAL IMPACT

BACKGROUND

On September 16, 2021, Governor Newsom signed Assembly Bill ("AB") 361 into law. AB 361 is urgency legislation amending the Brown Act to allow legislative bodies of local agencies to meet remotely with relaxed teleconferencing requirements during declared emergencies under certain conditions.

AB 361 adds new procedures and clarifies the requirements for conducting remote meetings, including the following:

• **Public Comment Opportunities in Real Time:** A legislative body that meets remotely pursuant to AB 361 must allow members of the public to access the meeting via a call-in option or an internet-based service option, and the agenda for the remote meeting must provide an opportunity for members of the

public to directly address the body in real time. A legislative body cannot require public comments to be submitted in advance of the meeting.

- **No Action During Disruptions:** In the event of a disruption that prevents the local agency from broadcasting the remote meeting, or in the event of a disruption within the local agency's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, AB 361 prohibits the legislative body from taking any further action on items appearing on the meeting agenda until public access to the meeting via the call-in or internet-based options is restored.
- **Periodic Findings:** To continue meeting remotely pursuant to AB 361, a legislative body must make periodic findings concerning the declared emergency and its effects. AB 361 will sunset on January 1, 2024.

The proposed resolution would make the findings required by AB 361 in order to allow AVTA to continue to make remote attendance available to its board members and the public if and to the extent needed.

- **WHEREAS**, Antelope Valley Transit Authority is committed to preserving and ensuring public access and participation in meetings of the Board of Directors; and
- **WHEREAS**, all meetings of Antelope Valley Transit Authority's legislative bodies are open and public, as required by the Ralph M. Brown Act (Cal. Gov. Code 54950 54963), so that any member of the public may attend, participate, and watch the Authority's legislative bodies conduct their business; and
- **WHEREAS**, the Brown Act, Government Code section 54953(e), makes provisions for remote teleconferencing participation in meetings by members of a legislative body, without compliance with the requirements of Government Code section 54953(b)(3), subject to the existence of certain conditions; and
- **WHEREAS**, a required condition is that a state of emergency is declared by the Governor pursuant to Government Code section 8625, proclaiming the existence of conditions of disaster or of extreme peril to the safety of persons and property within the state caused by conditions as described in Government Code section 8558; and
- **WHEREAS**, a proclamation is made when there is an actual incident, threat of disaster, or extreme peril to the safety of persons and property within the jurisdictions that are within the Authority's boundaries, caused by natural, technological, or human-caused disasters; and
- **WHEREAS**, it is further required that state or local officials have imposed or recommended measures to promote social distancing, or, the legislative body meeting in person would present imminent risks to the health and safety of attendees; and
- **WHEREAS**, such conditions now exist in the Authority, specifically, the Governor of California issued a series of Executive Orders aimed at containing the novel coronavirus; and
- **WHEREAS**, the State of California and County of Los Angeles recommend social distancing due to the coronavirus; and
- **WHEREAS**, the Board of Directors does hereby find that the threat of the coronavirus has caused, and will continue to cause, conditions of peril to the safety of persons within the Authority that are likely to be beyond the control of services,

personnel, equipment, and facilities of the Authority, and desires to proclaim a local emergency and ratify the proclamation of state of emergency by the Governor of the State of California; and

WHEREAS, as a consequence of the local emergency, the Board of Directors does hereby find that the Board of Directors of Antelope Valley Transit Authority shall conduct its meetings without compliance with paragraph (3) of subdivision (b) of Government Code section 54953, as authorized by subdivision (e) of section 54953, and that the Board of Directors shall comply with the requirements to provide the public with access to the meetings as prescribed in paragraph (2) of subdivision (e) of section 54953; and

WHEREAS, the Authority will post an agenda (72 hours in advance of a regular Board meeting and 24 hours in advance of a Special Board meeting) on the Authority's website at avta.com which will contain information on how the public can participate in the meeting and provide Public Comments.

NOW, THEREFORE, THE BOARD OF DIRECTORS OF ANTELOPE VALLEY TRANSIT AUTHORITY DOES HEREBY RESOLVE AS FOLLOWS:

- Section 1. <u>Recitals</u>. The Recitals set forth above are true and correct and are incorporated into this Resolution by this reference.
- Section 2. <u>Proclamation of Local Emergency</u>. The Board hereby proclaims that a local emergency now exists throughout the Authority's jurisdiction, and social distancing is recommended by the State of California and County of Los Angeles.
- Section 3. <u>Ratification of Governor's Proclamation of a State of Emergency</u>. The Board hereby ratifies the Governor of the State of California's Proclamation of State of Emergency, effective as of this Resolution's issuance date of October 26, 2021.
- Section 4. Remote Teleconference Meetings. The Executive Director/CEO and the Board of Directors of Antelope Valley Transit Authority are hereby authorized and directed to take all actions necessary to carry out the intent and purpose of this Resolution including, conducting open and public meetings in accordance with Government Code section 54953(e) and other applicable provisions of the Brown Act.

Services

RECOMMENDATION

That the Board of Directors authorize the Executive Director/CEO to negotiate and execute Amendment No. 11 to Contract #2011-032 with Transdev Services, Inc. for fixed route operations and maintenance services, effective January 1, 2022 through June 30, 2022, for an amount not to exceed \$10,000,000.00.

FISCAL IMPACT

Sufficient grant funds will be included in FY 2022 Mid-Year Budget Adjustments to pay for this service.

BACKGROUND

On May 31, 2021, AVTA staff released Request for Proposal (RFP) 2021-52, On-going Transit Operations and Maintenance Services, with a closing date of July 29, 2021. Eleven addenda were issue up to July 26, 2021. On July 27, 2021, Addendum 13 was issued by staff suspending the RFP until an internal review could be completed. Subsequently, staff released the RFP from suspension on October 7, 2021, establishing a final closing date of November 18, 2021. The RFP evaluation process, award and placement of a contractor by June 30, 2022, could be delayed for several reasons: 1) holiday season, 2) vacations and 3) Covid illnesses or other possible delays that we have encountered to date.

In order to properly plan and execute an all-encompassing fixed route operation and maintenance services contract for AVTA, staff respectively requests a six-month extension. The final contract amount will be fair and reasonable and be reported to the Board at the regular meeting in January 2022.

SUBJECT: WAVE System for AVTA Maintenance Depot

RECOMMENDATION

That the Board of Directors authorize the Executive Director/CEO to execute a purchase agreement with WAVE for a single WAVE charging system to be installed at the main facility. The system has been negotiated down to WAVE's current best pricing in the amount of \$255,000, plus applicable sales tax. Another \$150,000 is being requested to be reserved for installation.

FISCAL IMPACT

Funding is available in our 2021/2022 budget for the system and the installation.

BACKGROUND

As the first all-electric transit fleet in North America, AVTA has had the opportunity to discover a great deal about best practices for optimizing the performance of the fleet. As our experience with the electric fleet has accumulated, it has become apparent that having a WAVE system in the AVTA yard is a critical component in the effort to streamline and maximize the technician's time for troubleshooting and diagnostic processes, and testing and validating the repair. The system would also provide the enhanced ability for operations to top off low SOC buses for route relief purposes.
